OWNER'S STATEMENT

Share numbers 34, 35 and 36 sell in accordance with the terms and conditions of the syndicate agreement, a copy of which will be available at our consignment or in the Sales Office. The successful purchaser shall be entitled to breed 4 mares and receive 3 live foals per season for the life of the stallion. Bettor's Delight will stand in 2012 at Winbak of Canada, under the management of Blue Chip Farms of NY, for a stud fee of \$14,000 Cdn. In addition, the purchaser shall receive the share's pro rata portion of Southern Hemisphere income each year. All rights and obligations begin with the 2012 breeding season. This share represents a 3/122th ownership interest in the stallion and is NOT subject to right of first refusal by the syndicate members.
