## Separate Colt & Filly Races for 2 & 3 year old Trotters & Pacers

**Owned And Serviced By:** The Red Mile

**Sponsor:** The Red Mile, et al.

\*(Supplemental)

**For:**

Foals of 2002 (*Subject to U.S.T.A. Rule 26, section 26 (b)*, as published July 26, 2002, which specifies, "only a donor mare's first born embryo/ovum transfer foal each year will be eligible for registration;" The aforementioned rule shall not be affected by any subsequent rule changes or amendments.) With the exception of twins as defined by the U.S.T.A. Rule 26, section 22, only the first born foal from a mare will be eligible for nomination.

Nominated horses must be properly identified to the satisfaction of The Red Mile at the time of nomination, including but not limited to certifying that the nominated horse is registered as a twin or as the only foal of the mare in 2002, or, if produced through embryo/ovum transfer, is the donor's mare's first born foal in 2002. The Owner(s) of the nominated horse agree to indemnify and hold The Red Mile harmless from any and all claims, suits or damages, including attorney's fees, arising out of or related in any way to such certification.

**To Be Raced As:** Separate Colt & Filly Divisions for 2 & 3 year old Trotters & Pacers. To Be Raced in 2004 and 2005.

**Estimated Total Purse:**

**To Be Raced At:** The Red Mile, Lexington, KY during the Fall Grand Circuit meet.

**Cancellation:**

The Red Mile reserves the right to cancel any or all of the races if it becomes impractical or undesirable in the opinion of The Red Mile to conduct said races. If an event is not raced, The Red Mile's responsibility and liability shall be limited to refunding, without interest, all payments collected toward these events. These monies will be pro-rated among those owners of horses eligible at the time of cancellation.

**Added Money:**

The Red Mile and/or sponsors will add a minimum of \$5,000 for each two year old event and \$7,500 per division for each three year old event. The Association may deduct one percent of all money for administration, advertising and trophy costs for these events.

**Nomination Fee:** May 15, 2003; \$35 (US Funds only)

**Future Payments:** (US Funds only)

### On 2 year olds:

March 15, 2004	\$350
April 15, 2004	\$450
May 15, 2004	\$550
Declaration Fee	\$1,000
<b>*Supplemental Payment due March 15, 2004</b>	<b>\$550</b>

\*Ineligible two year olds may be made eligible to the two year old events in 2004 by making the two year old supplemental nomination fee on March 15, 2004 of \$550 plus the April 15 and May 15 payments.

### On 3 year olds:

February 15, 2005	\$550
March 15, 2005	\$750
April 15, 2005	\$850
Declaration Fee	\$1,000
<b>*Supplemental Payment due February 15, 2005</b>	<b>\$5,000</b>

\*Ineligible three year olds may be made eligible to the three year old events in 2005 by making the three year old supplemental nomination fee on February 15, 2005 of \$5,000 plus the March 15 and April 15 payments.

**Future Eligibility:**

In the event a two year old makes the March 15, 2004 payment and does not make any further payments, this horse is still eligible to make the February 15, 2005 payment

**Payment Distribution:**

Nomination fees will be divided equally between the eight races. Other payments may be credited to a specific race.

**Transfer of Gait:**

Eligibles may change gait at any time prior to declaration and must be qualified on the gait they have been declared. Payments already made will remain with the original gait.

**Declaration:**

Declaration fee shall be due at the time of declaration and payable before the horse starts. Declaration fees should be made payable to The Red Mile. There are no refunds for scratched horses. Qualifying standards for these events shall be those in effect for Added Money Races at The Red Mile.

**Notice:**

USTA Rule 11 Sec 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event."

**Racing Conditions:**

Each event to be raced one heat at one mile .In the event that more than twelve (12) horses declare to start, the race shall be split into divisions. If raced two divisions or more, the purse will be split in to as many divisions as necessary.

**Money Division:** 50%, 25%, 12%, 8% & 5%.

**Disputes:**

Decisions by the Executive Committee of The Red Mile shall govern all disputes arising from these conditions and their decision shall be final.

**Rules:**

Rules of The Red Mile, Kentucky Racing Commission and the USTA shall govern unless otherwise specified in these conditions.
