To Be Raced As: Separate Colt & Filly Divisions for two year old trotters and pacers.

Estimated Total Purse:

(2yo CT) \$200,000E	(2yo CP) \$325,000E
(2yo FT) \$200,000E	(2yo FP) \$250,000E

To Be Raced At: The Red Mile, Lexington, KY during the Fall Grand Circuit meet.

Cancellation:

The Red Mile reserves the right to cancel any or all of the races if it becomes impractical or undesirable in the opinion of The Red Mile to conduct said races. If an event is not raced, The Red Mile's responsibility and liability shall be limited to refunding, without interest, all payments collected toward these events. These monies will be pro-rated among those owners of horses eligible at the time of cancellation.

Added Money:

The Red Mile and/or sponsors will add a minimum of \$5,000 per division for each event. The Association may deduct one percent of all money for administration, advertising and trophies for these events.

STALLION NOMINATION FEE: May 15, 2002; \$1,000 (US Funds)

This payment, by a stallion owner, makes all 2002 foals by the stallion eligible to these stakes. If a stallion dies before this payment date, his foals may be made eligible to these stakes for a fee of \$200(US).

Future Payments: By owners of two year olds (US Funds only)

March 15, 2004.....	\$300
April 15, 2004.....	\$400
May 15, 2004.....	\$500
Declaration Fee.....	\$1,000

Supplemental Nomination/Declaration:

There shall be no supplemental nomination or declaration to these events.

Payment Distribution:

Stallion nomination fees will be divided equally among the four races. Other payments will be credited to the specific race.

Transfer of Gait:

Eligibles may change gait at any time prior to declaration and must be qualified on the gait which they have been declared. Payments already made will remain with the original gait.

Declaration:

Declaration fee shall be due at the time of declaration and payable before the horse starts. Declaration fees should be made payable to The Red Mile. There are no refunds for scratched horses. Qualifying standards for these events shall be those in effect for Added Money Races at The Red Mile.

Notice:

USTA Rule 11 Sec 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event."

Racing Conditions:

Each event will be raced one heat at one mile. In the event that more than fourteen (14) horses declare in to start, the race shall be split into divisions. If raced in two divisions or more, the purse will be split into as many divisions as needed.

Money Distribution: 50%, 25%, 12%, 8% & 5%

Disputes:

Decisions by the Executive Committee of The Red Mile shall govern all disputes arising from these conditions and their decision shall be final.

Rules:

Rules of The Red Mile, Kentucky Racing Commission and the USTA shall govern unless otherwise specified in these conditions. Decisions by the Executive Committee of The Red Mile shall govern all disputes arising from these conditions.
